# **CPS Express-ly for you!**

Look in your e-mail box on the first Monday of every month (Tuesday if Monday is a holiday) to get tips on recertifying and the latest information on the certification program.

The Express is emailed to the official email address in your CPS online profile and we update the list monthly. # **NHTSA Proposes First-Ever Side Impact Test for Child Restraint Systems**

CPS Technicians have long been asking about side impact testing standards. Exciting news! The U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) has proposed upgrades to the current FMVSS 213 to include side impact testing. The test simulates a vehicle traveling at 30 MPH crashing into the side of a small passenger vehicle traveling at 15

MPH.

The proposed test would include the currently available 12-month-old child crash test dummy and the newly designed 3-year-old crash test dummy with biometrics for side impact analysis. This would be a test for car seats sold in the U.S. that are designed for children weighing up to 40 pounds.

The agency's <u>Notice of Proposed Rulemaking</u> is being published in the Federal Register and members of the public will have the opportunity to comment on the proposal for 90 days.

### How should my head restraint be positioned?

To reduce the likelihood of a whiplash injury, head restraints should be positioned high enough to support the head so as to minimize neck distortion. Adjust the head restraint so that it's even with the top of your head. If it won't reach the top of your head, make it as high as it will go. For some people, no adjustment from the lowest position is required. If it's higher than the top of your head in the unadjusted position, that's OK, too.

The distance from the back of the head to the restraint should be as small as possible, preferably less than 4 inches. On seats without horizontally adjusting head restraints, this can be achieved by adjusting the seat's recline angle.

You may recertify up to four months before your certification expiration date without losing any time.

# Avoid problems--don't delay!

### Basic recertification requirements and deadlines:

- 1. <u>Five seat checks</u> approved by a certified instructor (you may use the technician proxy option). You can do the checks at any time during your certification cycle as long as they are entered online and a certified instructor approves them before your recertification date.
- 2. Community education (choose one):
  - Participation in at least one two-hour checkup event with at least one other CPS technician using any standardized checklist to provide documentation, if needed
  - o Provide at least four hours of community education. Examples include making presentations to parents, educators, kids, organizations (such as PTAs or law enforcement), or other stakeholders who are not technicians.
- 3. A minimum of six hours of <u>CPS technical continuing education units</u> earned and reported during a current two-year certification cycle.
  - You cannot carry over CEUs from one period to the next, even if you have accumulated more CEUs than are required
  - o Because your certification cycle stays the same, any CEUs obtained after you recertify but before the first day of your new certification cycle may not be applied to

- the new cycle
- You can record CEUs at any time during your certification cycle, but they must fit into one of the five approved categories and meet content requirements.
- 4. Register and pay the recertification fee before your certification expiration date. You can register up to 4 months in advance of your certification expiration date. You will NOT lose any time--your dates stay the same.

To get to the payment screen, you must have:

- Completed all five seat checks (entered and CPSTI approved)
- Entered at least six CEUs
- Entered your community event information

Once all three are done and you are within 4 months of your certification expiration date, you will see a "Click Here to Continue" button that will take you to the payment screens. Once your registration is complete, your recertification will be processed in no more than two days.

### Seat Checks for Recertification: Real or Mock?

Sometimes, in spite of our best efforts, we are not able to work with a real family for one or more of our 5 required seat checks required for recertification. If the Instructor or Tech Proxy is comfortable doing so, they can use a mock, or fake, scenario. Be sure to talk so there are clear expectations before the seat check.

The following guidelines were approved by the Certification/Recertification committee of the National CPS Board:

- During a seat check, it is always best to have the child present.
- Instructors and technicians are strongly encouraged to make every effort to do an actual safety seat checkup.
- If an actual caregiver is not available, the instructor/technician proxy may choose a mock scenario, where a colleague acts out the part of the parent.
- It is strongly encouraged that you enter your seat checks throughout your certification cycle, rather than waiting until near your certification expiration date.

Real or mock, an actual vehicle must always be used for seat checks.

Be sure to work on your recertification requirements during your certification cycle and don't wait until the end. Seat checks for recertification must be approved online by the instructor or tech proxy. They will receive an automatic notification email but please do email or call them if you are in a time crunch.

# **Latest Child Restraint Update Webinar Follow Up**

As you all know, the car seat world is constantly changing as new information becomes available. Since the webinar last week we have some additional information to share and one item to clarify.

For clarification, with the new Diono convertible line/booster seats (Ranier, Pacifica and Olympia), the Safe Stop is to be used for ALL forward facing installations with children who weigh 20-40 pounds. This is a change from their current seats, and is not applicable to the Radian, only the new seats coming out first quarter 2014.

#### Auditor Alcove: It's Here! It's Here!

While there may be some time before your next scheduled course, I have a few suggestions for all instructors, new and old. Read it cover to cover. Once. Twice. And a third time. The first read will be filled with excitement as you see what new things have been added and what outdated things have been removed. During the second read, take notes. Make highlights. Pay attention to those things that you know have changed so you can get yourself ready to present the new ideas. By the third read, you should have a good grasp of where everything is, how the course will flow, and you may even see something you missed during the first two reads.

Once you have finished your reads (do not forget about the quizzes, skills assessments, and planning & logistics guide), set up a meeting with your local instructors. During this meeting, compare notes, discuss ideas for presenting, and practice teaching. Schedule some follow-up either through phone calls or emails to explain what changes you will be making to your future courses.

Ahhhh, do you see that? You learn it, you practice it, and you explain it! LPE is not just for our courses!

### Featured FAQ: What is a CEU?

Generally, one hour of technical contact time counts for one continuing education unit (CEU), with a few specific exceptions. All categories of CEUs must meet the content requirements of improving CPS technical knowledge such as LATCH, a child restraint manufacturer workshop or CPS technical update. Non-technical CPS sessions, such as how to get funding or run an inspection station do not qualify.

Fact or Fiction: Vehicles are required when working with an instructor or tech proxy for your seat checks required for recertification.

**FACT:** The mock (AKA "buck") vehicle seat is a useful teaching tool when specific belt systems are not available during a course but they can't be used for this!

As described in the above article and on our <u>website</u>, real vehicles are required when working with an instructor or tech proxy for your seat checks required for recertification. At the discretion of the instructor or tech proxy, you can have a mock installation/communication scenario, but actual vehicles are always required.
