

CERTIFICATION UPDATES

Safe Kids Certification has undertaken an assessment of the certification program and has completed a workforce analysis of child passenger safety technicians and instructors. From those projects and feedback from the field we have several updates planned.

- Update to the Policy and Procedures Manual January 1, 2025
- Update to the CEU process and additional topics considered -January 1, 2025
- Required Online Instructor Course (must be completed once per certification cycle)
 Launch February 2025
 - o Approximately 1 hour
 - Will count as a CEU
 - Topics include Policy and Procedure, Course Administration, Code of Conduct, and Mentoring.
- Relaunch of https://training.safekids.org/ with an upgraded learning management system and updated CEUs Early 2025
- Option to receive text reminders for recertification (opt-in) Early 2025
- Translation of certification resources into Spanish Early Fall 2025

Nursing Contact Hours

Safe Kids does provide CNE for the CPST Certification course (students only) for both the in-person and hybrid deliveries. This nursing continuing professional development activity was approved by the Emergency Nurses Association, an accredited approver by the American Nurses Credentialing Center's Commission on Accreditation. The course will provide 24.0 contact hours of CNE. Course must be at least 30 hours. The Lead Instructor must notify Safe Kids about intent to provide CNE (at least 3 weeks in advance) – Safe Kids will confirm eligibility.

After the course, the lead instructor will send in the following paperwork.

One file with the Conflicts of Interest forms for each instructor

One file with the post evaluation summary (using activity evaluations for each instructor) We only need the summary page

One file with the daily rosters signed daily by nurses

You can choose to send in the application pages for the students or they can send them in individually. If the students are sending them on their own, please ask them not to send them until the course is complete, so we have the lead instructor's paperwork on file first.
